Our 2020-2021 fiscal year marked the 36th anniversary of Habitat for Humanity of Pinellas and West Pasco Counties. Thanks to your support, hundreds of homeowner partners have had the opportunity to improve their housing situations through a zero-percent interest mortgage, providing a safe and affordable place to live for years to come.

Through the commitment of our Habitat partner homeowners, board of directors, volunteers, donors and staff, our affiliate was able to make a deep impact in Pinellas and West Pasco Counties this past fiscal year:

- 60 homes completed in fiscal year 2020-2021 (July 2020 June 2021), despite navigating the pandemic.
- More than 50,000 volunteer hours helped construct these homes.
- A new ReStore location was opened in Palm Harbor to better serve our community at large.
- Habitat Pinellas and West Pasco received a 4 Star Charity Navigator rating and the Guide Star Platinum Seal of Transparency, which is the highest level of transparency.
- For the 4th consecutive year, Habitat Pinellas and West Pasco is ranked as the second largest affiliate based on new home construction, out of over 1,100 affiliates in the Habitat network.
- Partnerships were formed with Feeding Tampa Bay, Kids Pedal Power and other organizations in our community to make a greater imapact on the families we serve.

We are proud of our families for their dedication to improve not only their lives, but also the lives of their children. We thank you for continuing to support Habitat through your generous donation of time, talent and treasure.

# year in review















## building homes, community, and hope

Your contributions and volunteerism help Habitat make life-changing differences for struggling families and, in the process, positively impact our neighborhoods.

Every day, thousands of local hardworking families have to decide between paying rent or buying groceries. Monthly rent in the area has escalated, leaving a significant gap between what families can afford and what's available. We are working hard to make affordable homeownership a reality, because we believe everyone deserves a decent place to live.

Habitat served 60 families in fiscal year 2020 - 2021. Hard work and generosity made it possible for these homeowners to have something that most of us take for granted – peace of mind and a stable place for their children to thrive.

A hand up, not a handout. Habitat

homeowners work hard; they don't ask for handouts. At the end of the homeowner's journey they have put in at least 350 hours of "sweat equity," made a modest down payment and received a zerointerest mortgage. Our homeowners are physically and financially invested in their homes and are set on the right path toward responsible homeownership. The homeowner classes they are required to complete as part of their covenant with Habitat provide them with the tools to be successful homeowners and contributing citizens in their local communities.

In Florida, 1 in 6 households spend half or more of their income on housing. With help from our supporters, we can make the cost of home affordable for everyone. People are often surprised by how much we can

do with their donations. With as little as \$30 we can put up a wall in a Habitat home, buy several bags of concrete or a bundle of shingles. That is impressive, seeing as \$30 isn't enough to fill up a gas tank these days.

#### Even the smallest donations can make a big difference, and our supporters know their money is going to a good cause.

Habitat Pinellas and West Pasco received a 4 Star rating from Charity Navigator and the GuideStar Platinum Seal of Transparency. The Platinum Seal is the highest level of transparency, which means you can trust we are being responsible with your donations.

Habitat for Humanity of Pinellas and West Pasco Counties builds and sells homes at no profit and no interest to households who do not qualify for a traditional mortgage. Candidates that participate in our program are required to complete a variety of components to become successful homeowners, including sweat equity and educational classes.



The 2020-2021 fiscal year allowed for the preparation of the **Truist** Foundation sponsored Homeowner Education Center. The addition of a dedicated education center will enhance our program by providing a first-rate educational experience for our homeowners and our devoted instructors. The space includes three breakout rooms for one-on-one conversations with mentors thanks to Joe Trepani, Marion Rich and Republic Bank Foundation. And, thanks to Tibbetts Lumber Co. LLC, the Homeowner Selection Area will allow homeowners to make personal touches on their new home built through the program. As education is the cornerstone of the Habitat Homeownership Program, the buildout of this space will allow for greater impact throughout the community. Homeowners will experience transformational growth through this pillar of our program.

Gericka Brown, a single mother raising two children and working a full time job at Baycare Health System as a patient access service representative, achieved her dream of homeownership in 2021. She has a fiveyear-old daughter named Gabrielle, who is very excited to have her own room and to invite friends over for sleepovers. Gericka also recently welcomed a newborn baby boy named Onyx. "I am so very thankful for this opportunity to be able to provide a safe and stable home for my kids and I so they will be able to enjoy their own private space with a nurturing and loving environment."

Prior to Habitat, the Brown family moved in with Gericka's grandmother in her three bedroom, two bathroom home. They shared one bedroom while her grandmother and aunt occupied the others. "The conditions frequently brought stress upon the household because of limited space and freedom. I tried to remain positive and keep the energy afloat to make me and my daughter comfortable, but sometimes it was challenging trying to raise a child under someone else's roof."

After being accepted into the Habitat program, Gericka said "It was a dream come true that I finally have the opportunity to build a stable and positive environment for me and my kids. It was a very emotional moment, and I couldn't believe it at first."

"Owning my new home will give me a sense of maturity and responsibility. I will learn new characteristics throughout the entire journey." Gericka now has a sense of pride and ownership and has learned basic home maintenance to allow her to become more independent as a single mother.
