

Our 2019 - 2020 fiscal year marked the 35th anniversary of Habitat for Humanity of Pinellas and West Pasco Counties. Thanks to your support, hundreds of homeowner partners have had the opportunity to improve their housing situations through a zero-percent interest mortgage, providing a safe and affordable place to live for years to come.

In 2020, the importance of home was made clear for families all around the world due to the COVID-19 pandemic. While navigating the pandemic, our affiliate continued to make homeownership dreams a reality for local homeowner partners; ensuring their families had a safe place to call “home”. Through the commitment of our Habitat homeowner partners, board of directors, volunteers, donors and staff, our affiliate was able to make a deep impact in Pinellas and West Pasco Counties:

- 90 families served in fiscal year 2019 – 2020 (July 2019 – June 2020), including 54 new homes built.
- More than 41,000 volunteer hours supported home construction and our ReStores. Unfortunately due to the pandemic, volunteer opportunities were suspended in March of 2020.
- For the third consecutive year, Habitat Pinellas and West Pasco was ranked as the second largest affiliate based on new home construction, out of 1,049 affiliates, within the Habitat network.
- Affiliate leadership raised minimum pay to \$15 an hour for all employees.
- Habitat Pinellas and West Pasco was recognized regionally as a One Tampa Bay Honoree by the Tampa Bay Business Journal. We were recognized as a Tampa Bay Business Journal Business of Pride ally company honoree, which honors companies that have programs to ensure LGBTQ+ equality in the workplace. We also received the Community Service Award from the Suncoast Building Officials Association of Florida.
- Habitat Pinellas and West Pasco once again received the 4-Star Charity Navigator rating and GuideStar Platinum Seal of Transparency, which is the highest level of transparency for nonprofits.
- 95 cents of every dollar donated to Habitat Pinellas and West Pasco goes directly to building affordable homes for moderate-income families in our community!

We are proud of our families for their dedication to improve not only their lives, but also the lives of their children. We thank you for continuing to support Habitat through your generous donation of time, talent and treasure.

This year more than ever, your contributions and volunteerism help Habitat make life-changing differences for struggling families and, in the process, positively impact our neighborhoods.

A stable place to call home is essential to protecting your family and your community from Coronavirus. That's why our affiliate has continued our work to ensure individuals and families have a stable place to call home during this health crisis. We are working hard to make affordable homeownership a reality because we believe that everyone deserves a decent place to live.

Habitat served 90 families in the fiscal year of 2019 - 2020. Hard work and generosity made it possible for these homeowners to have something that most of us take for granted – peace of mind and a stable place for their children to thrive.

A hand up, not a handout. Habitat homeowners work hard; they don't ask for handouts. At the end of the homeowner's journey, they have put in at least 350 hours of "sweat equity," made a modest down payment and received a zero-interest mortgage. Our homeowners are physically and financially invested in their homes and set on the right path toward responsible homeownership. The homeowner classes they are required to complete as part of their covenant with Habitat provide them with the tools to be successful homeowners and contributing citizens in their local communities.

People are often surprised by how much we can do with their donations. With as little as \$30, we can put up a wall in a Habitat home, buy several bags of concrete or a bundle of shingles. That is impressive, seeing as \$30 isn't enough to fill up a gas tank these days.

Even the smallest donations can make a big difference, and our supporters know their money is going to a good cause.

For the third consecutive year, Habitat Pinellas and West Pasco received a 4 Star rating from Charity Navigator and the GuideStar Platinum Seal of Transparency. The Platinum Seal is the highest level of transparency, which means you can trust we are being responsible with your donations. Of every dollar donated, 95 cents goes to our homeownership program.

Our affiliate's leadership raised minimum pay to **\$15 an hour** for all Habitat employees.

We kicked off our **2020 Faith Build** with our homeowner partner, the Cottner family.

The inaugural Men's Build

was completed with Hunks with Hammers. The group dedicated the Moore family to Mark and his 5 nieces and nephews.

Habitat collected an overwhelming amount of **Hurricane Donations** for those worst affected by Hurricane Dorian.

The Pinellas ReStore opened the **BuildHer Boutique**, our new shopping experience of accessories and home goods.

Community leaders attended two **Community Builders Hours** which raised awareness and approximately **\$250,000 for our mission.**

The affiliate hosted the third annual **Paint the Block**, sponsored by Valspar and The Valspar Championship.

Over **100 volunteers served families** with exterior enhancements in Tarpon Springs.

Our affiliate was recognized as a **One Tampa Bay** honoree by the Tampa Bay Business Journal.

Our 9th Annual Golfing Fore Habitat tournament raised over **\$101,000** in support of our mission.

Our affiliate ended the year completing **18 Home Repairs** before sunsetting the program to focus on home builds.

Staff members were hard at work volunteering in Cambodia for the **Big Build Global Village Trip**.

Our staff donated their Thanksgiving Eve to completing beautification projects in the Tellor Estates community for our 4th annual **Give Back Day**.

The affiliate presented a check for over **\$858,000** to the Pinellas County Commission, representing the taxes paid by Habitat homeowners in 2019.

For the second year in a row, Habitat has partnered with **Denard Span Foundation, GTE Financial and Ferman Automotive** to provide a habitat homeowner with the opportunity to purchase a new vehicle at an affordable rate.

Breweries across Pinellas County came together to celebrate the **House That Beer Built** home dedication for the Beaton family.

The affiliate announced a **\$6 Million** affordable housing investment in partnership with Hancock Whitney Bank and Smith New Markets Tax Credit with a focus on South St. Petersburg.

We celebrated our **600th home** dedication in Ridgecrest with volunteers, elected officials, community partners and Habitat partner family, the Gordons.

We re-launched the **Legacy Builders Society** for members to leave a lasting impact on families in need of an affordable place to call home.

Members of our leadership team advocated for full funding of the **Sadowski Trust Fund** which was voted to be 100% for the first time in 10 years.

The affiliate launched a **new website** to better highlight homeowner stories.



We held the first annual **Community Builders Hour** event in Pasco to raise awareness for Habitat with local leaders.

The affiliate celebrated its **6th Annual Women's Build** with volunteers, sponsors, and the homeowner partner, the Munn family.

We were recognized as a **Business of Pride Honoree** by the Tampa Bay Business Journal.



