Driven by the vision that everyone needs a decent place to live, Habitat for Humanity empowers individuals and families to build and purchase their own homes with the community's support. The affiliate serves Pinellas, West Pasco, and Hernando Counties. Volunteers and future homeowners construct the homes, which are sold and financed with a zero-interest loan. Habitat homeowner candidates earn 30 to 80 percent of the area median income. Candidates must demonstrate the need for adequate shelter; the ability to pay back a zero-interest loan, and the willingness to partner with Habitat to complete a robust homebuyer education curriculum and invest 350 to 450 "sweat equity" hours.

Habitat ReStores are home improvement outlets where new and gently used building materials and home furnishings are sold at discounted prices. The ReStore sold donated furniture and construction supplies to the general public. Proceeds were used to fund the homeownership program. This operation was discontinued in March 2024. The closure allows the affiliate to be singularly focused on the homeownership program to address the need for affordable homeownership in our community.

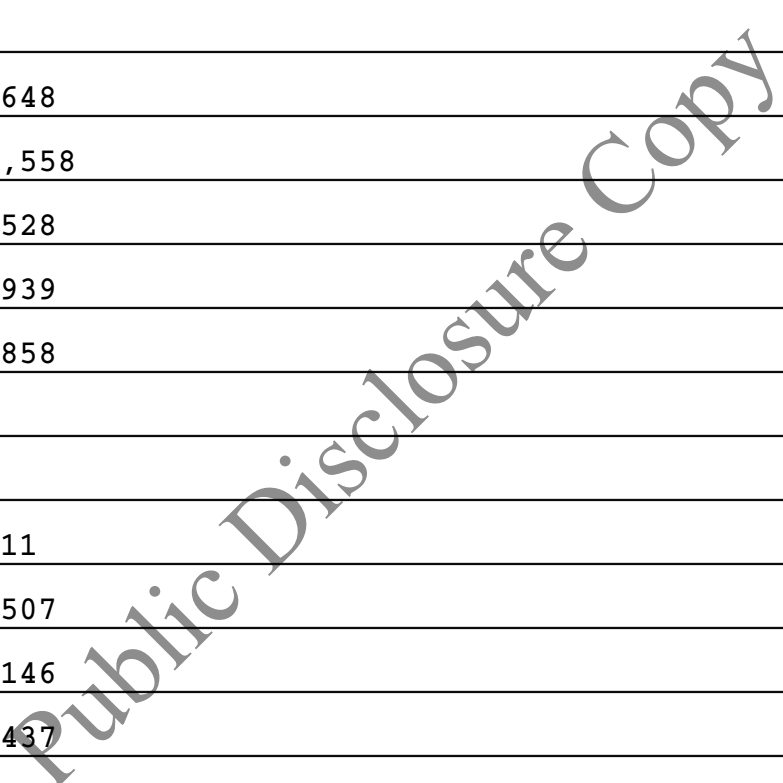

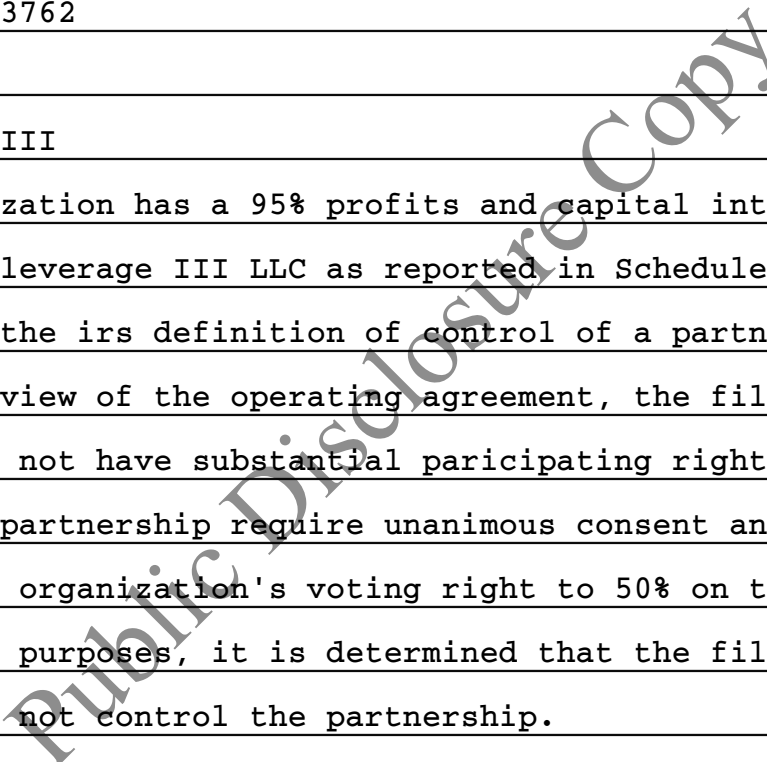
